SQUADRON TWO (VPU 2)

1. Purpose. To approve the disestablishment of VPU 1 and the consolidation of VPU 2 per reference (a).

2. Background. In accordance with Programming Objective Memorandum (POM) 12 efficiency review, disestablish VPU-1 at Naval Air Station Jacksonville, FL, and transfer aircraft and support equipment to VPU 2 at Marine Corps Base Hawaii. VPU 2's manning and mission will be modified.

3. Organizational Changes.
