1. Purpose. To implement Secretary of the Navy approval to disestablish subject shore activities and CNO approval of the consolidation of functions and relocation of Navy Operational Support Center (NOSC) Battle Creek per reference (a).

2. Background. The actions in this notice are the result of a 2008 CNO Excess Infrastructure Reduction Program which mandated the consolidation of the three Michigan NOSC's and their reserve units into a single site at NOSC Battle Creek and the consolidated NOSC to be relocated into a new and larger facility upon Fort Custer, Michigan.

3. Organizational Changes. Disestablish, consolidate and relocate subject commands effective 30 June 2012. The following applies:
