1. Purpose. To approve establishment of subject fleet activities per reference (a).

d. Director, Navy Staff (DNS-33) will revise reference (b).

5. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, which ever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
