DIEGO, CA

1. Purpose. To approve the modification of Naval Undersea Warfare Center Division Keyport (NAVUNSEAWARCENDIVKPT) Detachment Waiana, Waiana, HI and the establishment of NAVUNSEAWARCENDIVKPT Detachment San Diego, CA, per reference (a).

2. Background. The name of the detachment in Waiana is being changed to detachment Pacific to better reflect its area of responsibility and its location updated to Pearl Harbor as a result of a recent move. The new detachment being established in San Diego replaces an existing Naval Sea Systems Command (NAVSEASYS COM) established Naval Undersea Warfare Center component in San Diego and the establishment is the result of an increase in responsibilities for that component to the detachment level.

3. Organizational Changes

a. Modify and Establish. Effective 30 December 2012, modify NAVUNSEAWARCENDIVKPT Detachment Waiana and establish NAVUNSEAWARCENDIVKPT Detachment San Diego. The following applies:

c. Director, Navy Staff, Organization and Management Branch (DNS-33) will revise reference (b).

5. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
