Subj: MODIFY IMMEDIATE SUPERIOR IN COMMAND FOR TACTICAL
OPERATIONS CENTER SIGONELLA

Ref: (a) OPNAVINST 5400.44A
(b) OPNAVINST 5400.45

1. Purpose. To approve the modification of the immediate superior in command for the Tactical Operations Center (TOC), Sigonella, per reference (a).

2. Background. All other forward maritime patrol and reconnaissance forces (MPRF) TOCs are aligned under the forward geographic numbered fleet via the forward MPRF staff. The current TOC Sigonella alignment under Commander, Patrol and Reconnaissance Group was offered by Commander, U.S. Sixth Fleet (COMSIXTHFLT) as a necessary interim fix due to other higher priority Commander, U.S. Naval Forces Europe, U.S. Naval Forces Africa (COMUSNAVEUR) issues precluding the establishment of the TOC aligned under COMSIXTHFLT in time to be effective to meet the requirements. This action will align TOC Sigonella in COMSIXTHFLT under the geographic MPRF staff Commander, Task Force Sixty-Seven. There are no changes to location involved with the modification.

3. Organizational Changes. Modify reporting relationship for TOC Sigonella effective immediately. The following applies:

- 1 Chief of Naval Operations (00011)
- 2 Commander, U.S. Naval Forces Europe, U.S. Naval Forces Africa (00061)
- 3 Commander, U.S. Sixth Fleet (3818A)
- 4 Commander, Task Force Sixty-Seven (30191)
- 5 Officer In Charge, Tactical Operations Center Sigonella (55354)

4. Action

a. COMSIXTHFLT and COMUSNAVEUR must take appropriate action to effect the modification of the reporting relationships for TOC Sigonella.

b. This is advance change 40-15 to reference (b).

5. Records Management. Records created as a result of this notice, regardless of media or format, will be managed per Secretary of the Navy Manual 5210.1 of January 2012.

6. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
